



4.2 Impedance Characteristic



5.1 Test Conditions

Parts shall be measured under a condition (Temp.:20 $^{\circ}$ C ±15 $^{\circ}$ C, Humidity : 65%±20% R.H.).

6 ENVIRONMENTAL TEST

No.	Item	Test Condition	Remark
6.1	Humidity Test	The device is subjected to 90%~95% relative humidity $60^{\circ}C\pm 3^{\circ}C$ for 96h~98h,then dry out at $25^{\circ}C\pm 5^{\circ}C$ and less than 65% relative humidity for 2h~4h. After dry out the device shall satisfy the specification in table 1.	It shall fulfill the specifications in Table 1.
6.2	High Temperature Exposure	The device shall satisfy the specification in table 1 after leaving at 105°C for $96\text{h}{\sim}98\text{h}$,provided it would be measured after $2\text{h}{\sim}4\text{h}$ leaving in $25^{\circ}\text{C}\pm 5^{\circ}\text{C}$ and less than 65% relative humidity.	It shall fulfill the specifications in Table 1.
6.3	Low Temperature	The device shall satisfy the specification in table 1 after leaving at -40°C for 96h~98h, provided it would be measured after 2h~4h leaving in 25°C \pm 5 °C and less than 65% relative humidity.	It shall fulfill the specifications in Table 1.

6.4	Temperature Cycle	Subject the device to -40°C for 30 min. followed by a high temperature of 105°C for 30 min cycling shall be repeated 5 times. At the room temperature for 1h prior to the measurement.	It shall fulfill the specifications in Table 1.
6.5	Vibration	Subject the device to vibration for 2h each in $x \cdot y$ and z axis with the amplitude of 1.5mm, the frequency shall be varied uniformly between the limits of $10\text{Hz}\sim55\text{Hz}$.	It shall fulfill the specifications in Table 1.

6.7	Solder ability	Lead terminals are immersed in soldering bath of $260^{\circ}\text{C} \sim 290^{\circ}\text{C}$ for $3s \pm 0.5s$. More than 95% of the terminal surface of the device shall be covered with fresh solder.	The terminals shall be at least 95% covered by solder.
6.8	Terminal Pressure Strength	Force of 2kg is applied to each lead in axial direction for $10s\pm1$ s (see drawing). No visible damage and it shall fulfill the specifications in Fig 1	Mechanical damage such as breaks shall not occur.


